RATIONALE FOR THE COURSE:

Accounting is an information system which measures business activity and communicates the results to users. Accounting is the “language of business”, and the better someone understands the language, the better equipped that person will be to make informed decisions about the business.

COURSE DESCRIPTION:

This course introduces basic accounting procedures for analyzing, recording, and summarizing financial transactions, adjusting and closing the financial records at the end of the accounting cycle, and preparing financial statements.

1. Define merchandising activities and identify income components for a merchandising company.
2. Analyze and record transactions for merchandise purchases using a perpetual system.
3. Analyze and record transactions for merchandise sales using a perpetual system.
4. Define and prepare a multiple-step income statement.
5. Identify the items making up merchandise inventory.
6. Identify the costs of merchandise inventory.
7. Compute inventory in a perpetual system using the methods of specific identification, FIFO, LIFO, and weighted average.
8. Compute the lower of cost or market amount of inventory.

Unit #3

Materials Covered: Chapters 8, 9, and 10

***Assessment(s):** Homework problems, unit test, quizzes

Learning Outcomes:

1. Define internal control and identify its purpose and principles.
2. Prepare a bank reconciliation.
3. Describe accounts receivable and how they occur and are recorded.
4. Apply the allowance method and estimate uncollectibles based on sales and accounts receivable.
5. Describe a note receivable, the computation of its maturity date, and the recording of its existence.
6. Record the honoring and dishonoring of a note and adjustments for interest.
7. Explain the cost principle for computing the cost of plant assets.
8. Compute and record depreciation using the straight-line, units-of production, and declining-balance methods. 9. Account for natural resources and intangible assets.

Unit #4

Materials Covered: Chapters 11, 13, and 16

***Assessment(s):** Homework problems, unit test, comprehensive problem, quizzes

Learning Outcomes:

1. Describe current and long term liabilities and their characteristics.
2. Prepare entries to account for short term notes payable.
3. Compute and record employee payroll deductions and liabilities.
4. Compute and record employer payroll expenses and liabilities.
5. Explain how to account for contingent liabilities.
6. Record the issuance of corporate stock.
7. Record transactions involving cash dividends, stock dividends, and stock splits.
8. Record purchases and sales of treasury stock.
9. Prepare a statement of cash flows.
