RATIONALE FOR THE COURSE:

Accounting is the “language of business”, and it is used to communicate financial information, enabling managers to make informed decisions about the business. After completing this course you will have a basic knowledge and understanding of financial and managerial accounting.

COURSE DESCRIPTION:

This course provides students with an introductory review of basic financial processes of sports tourism that includes profit and non-profit and financial impact of sports tourism on the economy, community and environment.
