RATIONALE FOR THE COURSE:

This course is designed to provide the student with an advanced understanding of the refrigeration cycle through the study of the four major components. It is the foundation required for ACR 210.

COURSE DESCRIPTION:

This course is an introduction to the principles of air conditioning.

Labs

While some labs are practiced in groups, lab grades are based on an individual's achievement.
