RATIONALE FOR THE COURSE:

A study of troubleshooting refrigeration units associated with restaurants, hotels and supermarkets. Topics include food storage, ice machine and walk-in refrigerator maintenance, and preparation for the HVAC Excellence Refrigeration exam.

COURSE DESCRIPTION:

This course studies troubleshooting and maintenance of air conditioning equipment.
