RATIONALE FOR THE COURSE:

The purpose of this course is to provide the student with a thorough, comprehensive, sectional perspective of anatomy of the human body.

COURSE DESCRIPTION:

This course is a study of human anatomy as viewed in cross-sectional planes. This is used in imaging modalities, such as computed tomography, Magnetic Resonance Imaging, and Ultrasound.

PREREQUISITES/CO-REQUISITES: BIO 210. BIO 211

Part II: Student Learning Outcomes

COURSE LEARNING OUTCOMES and ASSESSMENTS*:

Refresh previous cross-sectional anatomy knowledge through exposure to images obtained via different modalities. In addition to computed tomography (CT) and magnetic resonance (MR) images, the learner will also study images from ultrasound and PET/CT. Learners will be required to identify structures on cross-sectional images as well as describe relationships between adjacent structures.

Upon completion of this course, the student will:

- A. Apply knowledge of cross sectional anatomy to obtain appropriate images in trans-axial, coronal, sagittal and oblique planes of all body systems,
- B. Apply knowledge of anatomical landmarks used for positioning, centering and determining scan completion for Computed Tomography imaging.
- C. Differentiate between normal and abnormal sectional anatomy to provide appropriate images for each procedure.
- D. Apply radiation safety principles and practices as prescribed by professional standards.
- E. Presents a specialized study of cross-sectional anatomy relevant to sectional imaging modalities such as computed tomography and magnetic resonance imaging.
