This course is intended to teach the student how to setup and operate a GE Fanuc Industrial Robot. Recommended safety procedures are integrated into all training exercises.

The course consists of lectures, demonstrations, and a series of lab exercises designed to reinforce what the student has learned.

COURSE DESCRIPTION:

This course includes assembling, testing, and repairing equipment used in automation. Concentration is on connecting, testing, and evaluating automated controls and systems.
