### **RATIONALE FOR THE COURSE:**

Art is more than the creative manifestation of human expression. By studying process and progress of visual and tactile Western art from the Renaissance through modern times, the student will enhance creative thinking skills (especially judgment), will expand the senses and mind with a greater appreciation of beauty and will acquire a better ability to comprehend the human impulses of everyday life (a necessary skill in today's workplace).

#### **COURSE DESCRIPTION:**

This course is a visual and historical survey of western art from the Renaissance through modern times. The techniques, forms, and expressive content of painting, sculpture, and architecture will be studied within the context of the cultural environment which produced them.
