#### **RATIONALE FOR THE COURSE:**

This course exposes students to the world of advertising, forms an understanding of advertising designs and allows exploration of advertising campaigns along with a deeper understanding of design theory and client interaction.

#### **COURSE DESCRIPTION:**

This course is an introduction to the advertising arts, including the principles, techniques, media, tools, and skills used in the visual communication field.

#### PREREQUISITES/CO-REQUISITES:

Prerequisites: ARV 121 and ARV 210 and ARV 162 (with a grade of C or higher or TC or higher)

Corequisites: ARV 163

#### **GRADING SYSTEM:**

Please note the College adheres to a 10 point grading scale A = 100 - 90, B = 89 - 80, C = 79 - 70, D = 69 - 60, F = 59 and below. You must have your Dean's approval if changes in the scale are made.

Grades earned in courses impact academic progression and financial aid status. # **Part IV: Attendance**

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. **Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.**
