# **RATIONALE FOR THE COURSE:**

This course further exposes students to the world of advertising, forms a deeper understanding of advertising designs and allows further exploration of advertising campaigns along with a deeper understanding of design theory and client interaction. This course also prepares students' professional portfolio and ends in a public showcase, where students present their work to art and design professionals.

# **COURSE DESCRIPTION:**

This course covers advanced knowledge, practices, and skills in the visual communication field.

ARV 261 (Advertising Design I) Minimum Grade of C

#### **GRADING SYSTEM:**

# Part IV: Attendance

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.
