### **RATIONALE FOR THE COURSE:**

AUT-131 is a required course in the Automotive Technology Program and will cover basic electrical theory, electrical component operation, automotive communication networks, hybrid / EV safety and operation.

### **COURSE DESCRIPTION:**

This course is a study of the individual systems and components that when combined form the entire automobile electrical system. The course includes starting and charging systems, ignition, engine, chassis, and accessory systems as well as instruction in the proper use of electrical schematics.

## **Part II: Student Learning Outcomes**

After this course of study each student will understand basic electrical theory, have the ability to read an electrical diagram, understand automotive communication systems, and demonstrate hybrid/EV safety procedures and operation.

#### **Tests**

Unit tests and lab tests are used to assess knowledge and skills. Make up tests and labs will be given at the instructor's convenience. It is the **responsibility of the student** to arrange with the instructor a time to make up a test. Cell phone use during a test is considered cheating.

#### **Topics of study**

The following topics will be studied and discussed in detail, although the order of presentation may not exactly follow the attached listing. The instructor may introduce additional materials.

Week 1-3 Basic electrical theory, Ohms law, series/parallel circuits.

Week 4-7 Computer inputs, outputs, and communication operation

Week 8-10 Understanding proper sensor voltages and readings.

Week 9-12 Hybrid/EV safety and operation

Week 13-14 Course review.

#### **Labs**

Lab work is a key element to having a working knowledge of the materials being presented in this course. Students must demonstrate adequate skills and procedures to be given a passing grade. Labs will be assigned based on equipment and space availability. Labs are assigned with an objective and deadline. While some labs are practiced in groups, lab grades are based on an individual's achievement.

**Students will be expected to perform hands-on lab projects. These projects could stain or damage**
