RATIONALE FOR THE COURSE:

To provide students with advanced plated dessert techniques that will prepare them for retail restaurant or banquet dessert employment.

COURSE DESCRIPTION:

This course focuses on the elements of modern dessert production and consumption. It stresses a thorough understanding and creation of all components of plated dessert production, using basic pastry principles.

- Select and use basic pastry/bakery equipment under different production scenarios
- List and define terminology specifically related to the production of pastry/baked goods
- Scale ingredients and cost items accurately
- Prepare a variety of basic dessert components
- Prepare and manage a prep list
- Prepare and manage a timeline for production
- Prepare menus for presentation of desserts
- Produce pastries using classical materials, pate a choux and puff pastry
- Identify and explain the following terms as they apply to the pastry/baking process

Employability Skills:

Fowler Dessert Production and Fabrication (100-point scale) for 30% of Final Grade

There are 5 parts to the Fowler Dessert Process

- 1. Menu presented to Dining room Monday worth 6% of points
- 2. Game Plan for Dessert 6% of points
- 3. Final picture of finished dessert worth 6% of points

- 4. Bread picture with game plan worth 6% of points
- 5. Friandise picture with game plan worth 6% of points

These five parts will be explained in detail at the end of week one, during lecture.
