## RATIONALE FOR THE COURSE:

This course reinforces the knowledge and skill learned in the preceding classes and helps students build confidence in the techniques of basic fundamental baking, pastry and develops advanced dessert production procedures in a restaurant or bakery service setting. The development of communication, teamwork, customer service, and ability to work in a professional pastry foodservice environment is accentuated. The concepts of mise en place, timelines, production, and a solid understanding of chocolate and sugar candy foundations. Timing and organization skills are emphasized.

## COURSE DESCRIPTION:

This course is a study of chocolate artistry and sugar work to include tempering various types of chocolate for modeling and display work, as well as molding, pulling, and production of chocolate and sugar confections.
