RATIONALE FOR THE COURSE:

This course is designed for students to work in an approved business industry related site. In this setting they will gain hands on experience, in many areas, to include: business operations, customer service, marketing, database management, product management, sales, as well as other business related areas specific to the site.

COURSE DESCRIPTION:

This course includes the integration of business skills within an approved work site related to business and industry.

PREREQUISITES/CO-REQUISITES:

(Credit level MKT 101 Minimum Grade of B or Credit level MKT 101 Minimum Grade of TB) or (Credit level MGT 101 Minimum Grade of B or Credit level MGT 101 Minimum Grade of TB) or (Credit level ACC 101 Minimum Grade of B or Credit level ACC 101 Minimum Grade of TB) and (Credit level BUS 101 Minimum Grade of B or Credit level BUS 101 Minimum Grade of TB)

***Online/Hybrid** courses require students to complete the DLI Online Student Orientation prior to completing an online course. The DLI Online Student Orientation can be found in WaveNet, under the My Student tab.

REQUIRED MATERIALS:

There is no textbook for this course.

This course is graded on a satisfactory/unsatisfactory basis. Learning objectives must be established and 180 hours (or more) of work in a semester must be completed. There is a project component that must be completed by the student in order to successfully complete the internship.

GRADING SYSTEM:

The Business Department has a seven day grading policy. Please note the College adheres to a 10 point grading scale A = 100 – 90, B = 89- 80, C = 79 – 70, D = 69 – 60, F = 59 and below. You must have your Dean's approval if changes in the scale are made.

Grades earned in courses impact academic progression and financial aid status. Before withdrawing from a course, be sure to talk with your instructor and financial aid counselor about the implications of that course of action. Ds, Fs, Ws, WFs and Is also negatively impact academic progression and financial aid status.

The Add/Drop Period is the first 5 days of the semester for **full term** classes. Add/Drop periods are shorter for accelerated format courses. Please refer to the academic calendar for deadlines for add/drop ([ACADEMIC CALENDAR](#)). You must attend at least one meeting of all of your classes during that period. If you do not, you will be dropped from the course(s) and your Financial Aid will be reduced accordingly.

Part IV: Attendance

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. **Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.**

For online and hybrid courses, check your Instructor's Course Information Sheet for any required on-site meeting times. Please note, instructors may require tests to be taken at approved testing sites, if you use a testing center other than those provided by HGTC, the center may charge a fee for its services.
