#### COURSE LEARNING OUTCOMES and ASSESSMENTS\*:

#### Module #1

Materials Covered: Chapters 1 and 2 \*Assessment: Test 1

Learning Outcomes:

- 1. Name examples of the various rock formations and describe processes by which they are weathered.
- 2. Explain the difference between AASHTO and USCS sand designations.
- 3. Obtain useful soil data from lab experiments such as grain-size determination and Atterberg limits.
- 4. Construct block diagrams showing soil components and (based on lab data) calculate soil properties such as void ratio, moisture content, etc.

### Module #2

Materials Covered: Chapters 3, 4 and 5 \*Assessment: Test 2

Learning Outcomes:

1. Be able to use Coulomb's equation to estimate the shear strength in soils.

- 2. Describe numerous methods of sampling soils; perform various soils tests such as the cona and vane penetration tests and the standard proctor compression.
- 3. Discuss terms related to the permeability of a soil.
- 4. Be able to predict the water flow rate through soil using Darcy's Law and the flow pattern through soils by using the concept of flow nets.
- 5. Be able to compute vertical soil stresses beneath footings of various shapes using several different methods.

### Module #3

Materials Covered: Chapters 6, 7 and 8 \*Assessment: Test 3

Learning Outcomes:

- 1. Be able to differentiate between primary and secondary consolidation settlement in soils and to determine from an "e vs. log p" graph (developed in lab) whether a clay is normally or over-consolidated.
- 2. Be able to estimate soil shear capacities with Coulomb's equation and to determine lab and field estimates of soil shear strengths by various methods.

#### **GRADING SYSTEM:**

Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance.
