#### **RATIONALE FOR THE COURSE:**

To introduce the student to the fundamental principles of hydrostatics, mass, specific gravity, loads, and buoyancy under static conditions. Hydrodynamic principles of fluid flow will be studied to develop the necessary skills for the study of pumps and water and sewer distribution and collection systems. Fundamentals of hydraulics, fluids flow, Bernoulli's equation and applications, head loss, flow through pipes, open channels, weirs and orifices, flow measurement, and use of computer spreadsheets to solve typical hydraulics problems involving Hazen-Williams and Hardy Cross.

#### **COURSE DESCRIPTION:**

This course includes the fundamentals of flow, control, disposal of water, and flow through open and closed conduits, orifices, and weirs.
