### **RATIONALE FOR THE COURSE:**

This course is the study of reinforced concrete structures. The course includes an overview of the aggregates, admixtures and water cement ratios used in a concrete mix. It includes the analysis and design of rectangular beams, slabs and T- beams under tension, compression and in shear. It also covers the development (embedment) lengths and splicing requirements for steel bars. In addition, there will be an introductory study of column analysis and design. The contents of this course are in accordance with the current issue of the American Concrete Institute Building Code (ACI 318).

### **COURSE DESCRIPTION:**

This course covers the design of concrete structural members according to the ACI codes, quality control of concrete, and structural inspection.

### **COURSE LEARNING OUTCOMES and ASSESSMENTS\*:**

- 1. Identify the basic aggregates and admixtures used in concrete mixes.
- 2. Perform sieve analysis for both fine and coarse aggregates in accordance with ASTM standards.
- 3. Proportion a basic concrete mix design ranging from 3,000 psi to 4,500 psi.
- 4. Perform a slump test in accordance with ASTM standards.
- 5. Perform 7-day and 28-day compression tests in accordance with ASTM standards.
- 6. Perform air-entrainment test in accordance with ASTM standards.
- 7. Relate to the ACI 318 Building Code.

- 8. Perform analysis and design calculations for simply supported rectangular beams under tension.
- 9. Perform analysis and design calculations for T-beams under tension.
- 10. Perform analysis and design calculations for shear stresses in a rectangular beam.
- 11. Calculate development length of rebar under both tension and compression stresses.
- 12. Perform analysis and design calculations of reinforced concrete columns.
