### **RATIONALE FOR THE COURSE:**

This course is designed to provide the student with basic theory and practices of highway design using SCDOT requirements and Civil 3D software.

### **COURSE DESCRIPTION:**

This course covers a study of the design and construction of a highway.

### PREREQUISITES/CO-REQUISITES:

(Credit level MAT 110 Minimum Grade of C or Credit level MAT 110 Minimum Grade of TC or Credit level MAT 175 Minimum Grade of C or Credit level MAT 175 Minimum Grade of TC or Multiple Measures Math 1) and (Credit level EGR 275 Minimum Grade of C or Credit level EGR 275 Minimum Grade of TC)

- 5. Student will be able to design a highway drainage system.

- 7. Student will be able to calculate earthwork volumes from cross sections.
- 8. Student will be able to design a culvert to carry storm water under the roadway.
- 9. Student will be able to do a quantity takeoff and prepare an estimated construction cost.
