### **RATIONALE FOR THE COURSE:**

Completion of CHM 211 enables the student to gain an appreciation and working knowledge of concepts related to the study of carbon compounds. These principles are approached through the development of problem-solving skills, which helps prepare students for future careers in science fields. Some of the concepts introduced in general chemistry will be expanded upon, while many course topics will be new. Students will also be exposed to organic chemistry through a series of "hands-on" laboratory experiments, which will be beneficial to careers that include scientific research.

### **COURSE DESCRIPTION:**

This is the first of a sequence of courses that includes nomenclature, structure and properties, and reaction mechanisms of basic organic chemistry. This course is transferable to public senior institutions as part of the South Carolina Commission on Higher Education Statewide Articulation Agreement.

### **PREREQUISITES/CO-REQUISITES:**

(Credit level CHM 111 Minimum Grade of C or Credit level CHM 111 Minimum Grade of TC)

Laboratory safety glasses will be provided, but students may bring their own pair if desired.

After viewing the presentation, all online students must complete the orientation quiz, which can be found under the dropdown assignment menu. A student will not be considered officially enrolled in the course until the presentation has been viewed and the quiz completed with a 100% score. Any submitted work from the student including discussion posts, assignments, etc. will not be given a grade until the presentation has been viewed and the quiz has been submitted. Failure to view the presentation and take the quiz before midnight on the last day to add/drop classes will result in the student being automatically dropped from the course.

## **Part II: Student Learning Outcomes**

### **COURSE LEARNING OUTCOMES and ASSESSMENTS\*:**

A student will demonstrate an understanding of organic chemical bonding and molecular structure by:  
creating Lewis electron-dot structures for various molecules.  
applying formal charges to atoms in molecules.  
identifying constitutional (structural) isomers, and distinguishing from resonance forms.

naming and determining structures for alkanes, alkenes, alkyl halides and alcohols.  
illustrating and interpreting different conformations of alkanes and ranking their relative stabilities.  
utilizing the orbital hybridization model of bonding to identify  $sp^2$  and  $sp^3$  carbons.  
distinguishing between  $\sigma$ - and  $\pi$ -bonds in organic molecules.  
identifying chiral carbons and distinguishing stereoisomers by R-, S- nomenclature.  
interpreting Fischer projections in terms of chirality.  
distinguishing enantiomers and diastereomers using Fischer projections, wedge-and-dash structures, and R-,S-nomenclature.

A student will demonstrate an understanding of organic reactions by:

interpreting mechanisms for  $S_N1$  and  $S_N2$  reactions involving alcohols and alkyl halides.  
predicting the products of reactions involving interconversion of alcohols/alkyl halides.  
predicting relative carbocation and carbon free radical stabilities.  
interpreting mechanisms for free radical halogenations.  
interpreting mechanisms for E1 and E2 elimination reactions.  
distinguishing alkenes by cis/trans and E/Z nomenclature.  
utilizing Zaitsev's rule to predict products of alcohol elimination.  
utilizing Markovnikov's rule to predict products of alkene addition reactions.  
predicting the products of hydroboration-oxidation, halogen addition, and halohydrin reactions.  
predicting the outcome of  $S_N1$  and  $S_N2$  reactions regarding stereochemistry of products.  
outlining reaction sequences needed to prepare various target molecules from given starting materials.

### **Lab Student Learning Outcomes:**

Learning outcomes for the lab portion of this course are the Objectives given for each lab in the manual and can be found at the start of each lab. They include hands-on items such as identification and proper use of lab equipment, and various experimental techniques.

## **GRADING SYSTEM:**

Please note the College adheres to a 10 point grading scale A = 100 – 90, B = 89- 80, C = 79 – 70, D = 69 – 60, F = 59 and below.

Grades earned in courses impact academic progression and financial aid status. The Add/Drop Period is the first 5 days of the semester for **full term** classes. Add/Drop periods are shorter for accelerated format courses. If you do not, you will be dropped from the course(s) and your Financial Aid will be reduced accordingly.

## **Part IV: Attendance**

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. **Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.**

**For online and hybrid courses**, check your Instructor's Course Information Sheet for any required on-site meeting times. Please note, instructors may require tests to be taken at approved testing sites, if you use a testing center other than those provided by HGTC, the center may charge a fee for its services.

### **Lecture Attendance:**

For a 15-week course (fall and spring), the allowed number of absences for a MW or TR class is as follows: 6 absences are allowed for lecture, regardless of reason. For a lecture class that meets once a week, the allowed number of absences is three (3). When a student surpasses the allowed number of absences, the student will be dropped automatically from the course with a W or a WF. Remember, an absence is an absence, no matter if it is excused or not!

### **Lab Attendance:**

Students are allowed two (2) lab absences for a lab that meets weekly. When a student surpasses the allowed number of absences, the student will be dropped automatically from the course with a W or a WF.

### **Online/Hybrid Attendance:**

Students enrolled in distance learning courses (hybrid and online) are required to maintain contact with

the instructor on a regular basis to be counted as "in attendance" for the course. All distance learning students must participate weekly in an Attendance activity in order to demonstrate course participation. Students showing no activity in the course for two weeks (these weeks do not need to be consecutive) will be withdrawn due to lack of attendance.

### **Lab Attendance for Hybrid Courses:**

Students in hybrid classes in which labs only meet 5 or 6 times during the semester, must attend all lab sessions for its entirety. Failure to attend one lab will result in immediate withdrawal. Students in hybrid classes where labs meet every week, you are allowed one lab absence. When a student surpasses the allowed number of absences, the student will be dropped automatically from the course with a W or a WF.

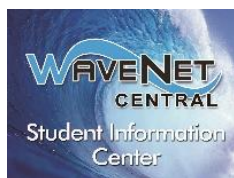
