RATIONALE FOR THE COURSE:

This course gives students the foundational knowledge of basic web design theory and ideas around color theory and layout of web pages along with graphics and animation.

COURSE DESCRIPTION:

This course is the study of web design techniques including layout, graphics, and interactivity. Graphics and animation software will be taught.

Pre-Requisite: CPT187 Object-Oriented Logic and Design (Grade of "C" or "TC" or higher)

Co-Requisite: IST226 Internet Programming

GRADING SYSTEM:

Grades earned in courses impact academic progression and financial aid status. Before withdrawing from a course, be sure to talk with your instructor and financial aid counselor about the implications of that course of action. Ds, Fs, Ws, WFs and Is also negatively impact academic progression and financial aid status.

The Add/Drop Period is the first 5 days of the semester for **full term** classes. Add/Drop periods are shorter for accelerated format courses. Please refer to the academic calendar for deadlines for add/drop ([ACADEMIC CALENDAR](#)). You must attend at least one meeting of all of your classes during that period. If you do not, you will be dropped from the course(s) and your Financial Aid will be reduced accordingly.

Part IV: Attendance

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. **Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.**

For online and hybrid courses, check your Instructor's Course Information Sheet for any required on-site meeting times. Please note, instructors may require tests to be taken at approved testing sites, if you use a testing center other than those provided by HGTC, the center may charge a fee for its services.

Information Technology Department Attendance for Face-to-Face Courses Policy:

For a 14-week course (fall and spring) the allowed number of absences for a MW or TR class is as follows: 3 absences are allowed regardless of reason. After the allowed number of absences, the student will be withdrawn from the course with a W or a WF. A course meeting once a week as a hybrid course, will also be permitted 3 absences during fall and spring only.

For a 10-week course (summer) the allowed number of absences for courses meeting twice a week is 3 absences. For a course during the summer meeting once a week (hybrid) or online, 2 absences are permitted. After missing the maximum number of allowed absences, a student will be withdrawn from the course with a W or a WF.

Online/Hybrid Attendance:

Students enrolled in distance learning courses (hybrid and online) are required to maintain contact with the instructor on a regular basis to be counted as "in attendance" for the course. All distance learning students must participate weekly in an Attendance Discussion Board in order to demonstrate course participation. Students showing no activity in the course for two weeks will be withdrawn due to lack of attendance.
