### **RATIONALE FOR THE COURSE:**

At the completion of this course, the student will have the fundamental skills to perform as a Cybersecurity Analyst, explain the Windows Operating System features that support cybersecurity analyses, operate the basic features of the Linux Operating Systems, identify the Threat Actors, work to identify network security incidents and analyze the different protocols that are vulnerable to attack.

### **COURSE DESCRIPTION:**

This course is the study of the protection of information and equipment in computer systems. Topics include all aspects of systems protection, including physical security, hardware, software and communications security. Addresses technical, legal and ethical issues.

### **GRADING SYSTEM:**

HGTC has a standardized grading system which adheres to a 10-point grading scale A = 100 – 90, B = 89- 80, C = 79 – 70, D = 69 – 60, F = 59 and below.

Grades earned in courses impact academic progression and financial aid status.
