RATIONALE FOR THE COURSE:

This course is designed for students who intend to move into managerial roles in culinary operations. As such, this course will emphasize the development of practical purchasing skills in seven major areas – determining (1) what to sell, (2) what to buy, (3) who to buy it from, (4) how much to buy, (5) how to get the best deal, (6) how to actually purchase items, and (7) how to keep track of purchased items.

COURSE DESCRIPTION:

This course combines purchasing theory with practical experience in the storeroom. Students develop skills in purchasing, developing requisitions, food transfers, inventory and organization of the storeroom.
