- 2. Utilize critical analysis and problem-solving skills in the provision of dental hygiene care.

- 4. Utilize infection control protocols for prevention of disease transmission through demonstration of proper sterilization and disinfection methods, barrier techniques and maintenance of asepsis.

 - Medical and dental history
 - Extraoral and intraoral examinations
 - Dental and periodontal evaluations and chartings
 - Risk factor assessment

 - Treatment plans for comprehensive dental hygiene care
 - Scaling & root planning
 - Coronal polishing
 - Dental Sealants
 - Placement of Arestin
 - Oral Health Education for each patient
 - Fluoride procedures for indicated patients
 - Comprehensive treatment plans for a child, adolescent, adult, and geriatric patient
 - Calculus detection

- Ultrasonic instrumentation and Use of Air Polishing
- Delivery of Local Anesthesia Infiltration when indicated
- 6. Utilize proper dental hygiene care in providing total oral health care for the patient with special needs.
- 7. Prescribe the appropriate post-operative procedures and instructions for the patient.
- 8. Adequately document all treatment in the patient's chart.
- 9. Demonstrate professionalism in working with peers, faculty, and patients.
- 10. Take diagnostically acceptable radiographs
- 11. Demonstrate proficiency in radiographic interpretation
- 12. Perform non-patient clinical assisting duties

*The TalEval program will be utilized to track classifications of patients for patient care categories (age), as well as periodontal and calculus skill levels. Students must be deemed competent on at least one patient in each age category and periodontal disease skill level to progress to the next semester.

<u>To meet competence</u>, students must successfully complete treatment within each patient care category and classification of periodontal disease without a critical error.

• Critical errors are defined within TalEval as any error that compromises patient safety, patient-centered care, ethics, and professionalism.

GRADING SYSTEM:

A =90-100 B=80-89 C=77-79 D=70-76 F=69 or lower Students must pass with a 77% or higher to continue in the Dental Hygiene Program.

Grades earned in courses impact academic progression and financial aid status. Before withdrawing from a course, be sure to talk with your instructor and financial aid counselor about the implications of that course of action. Ds, Fs, Ws, WFs and Is also negatively impact academic progression and financial aid status.

The Add/Drop Period is the first 5 days of the semester for **full term** classes. Add/Drop periods are shorter for accelerated format courses. Please refer to the <u>academic calendar</u> for deadlines for add/drop. You must attend at least one meeting of all of your classes during that period. If you do not, you will be dropped from the course(s) and your Financial Aid will be reduced accordingly.

Part IV: Attendance

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet. Refer to the HGTC Dental Sciences Program Manual for additional policies on attendance.

For online and hybrid courses, check your Instructor's Course Information Sheet for any required on-site meeting times. Please note, instructors may require tests to be taken at approved testing sites, if you use a testing center other than those provided by HGTC, the center may charge a fee for its services.
