This course provides an introduction into the structure and design of hydraulic systems and their components.

This course covers the theory, application, testing, and repair of diesel and heavy equipment hydraulic systems.

## Part II: Student Learning Outcomes

### **COURSE LEARNING OUTCOMES and ASSESSMENTS\*:**

After this course of study the student should be able to: Understand how an internal combustion engine

works as well as the history and evolution of the diesel engine. Students should know, understand and explain how a diesel works internally and the different features of two-stroke versus four-stroke engine designs.

### **Tests**

Unit tests and lab tests are used to assess knowledge and skills. Make up tests and labs will be given at the instructor's convenience. It is the **responsibility of the student** to arrange with the instructor a time to make up a test. Cell phone use during a test is considered cheating.

### **Topics of study**

The following topics will be studied and discussed in detail, although the order of presentation may not exactly follow the attached listing. The instructor may introduce additional materials.

Week 1-4 Introduction to Hydraulics Safety, Principles, and Symbols

Week 5-6 Pumps, Actuators, Valves, and Cylinders

Week 6-7 Filtration, Contamination, Coolers, and Plumbing

Week 8-10 Pressure Compensation, Load Sensing Compensation, and Flow Sharing Compensation

Week 11-12 Pump Controls and Troubleshooting Principles

Week 13-15 Hydrostatic Drives and Steering

### **Labs**

Lab work is a key element to having a working knowledge of the materials being presented in this course. Students must demonstrate adequate skills and procedures to be given a passing grade. Labs will be assigned based on equipment and space availability. Labs are assigned with an objective and deadline. While some labs are practiced in groups, lab grades are based on an individual's achievement.
