### **RATIONALE FOR THE COURSE:**

This course is designed for second year students to fully observe, implement and comprehend the important process of ITERS. ITERS is the Infant Toddler Environmental Rating Scales for day care and preschools in South Carolina. Students will gain knowledge of infant brain development and growth into toddler ages.

### **COURSE DESCRIPTION:**

This course is a study of Infant and Toddler care. Emphasis is on brain development and its implications for caring for infants and toddlers. Planning and teaching strategies as they relate to child development, curriculum and environment are included in the course.

### **GRADING SYSTEM:**

Please note the College adheres to a 10 point grading scale A = 100 – 90, B = 89- 80, C = 79 – 70, D = 69 – 60, F = 59 and below. You must have your Dean's approval if changes in the scale are made.
