### RATIONALE FOR THE COURSE:

This course is designed for second year students to fully observe, implement and comprehend the important process of ITERS. ITERS is the Infant Toddler Environmental Rating Scales for day care and preschools in South Carolina. Students will gain knowledge of infant brain development and growth into toddler ages.

### COURSE DESCRIPTION:

This course is a study of Infant and Toddler care. Emphasis is on brain development and its implications for caring for infants and toddlers. Planning and teaching strategies as they relate to child development, curriculum and environment are included.

Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. **Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.**
