### **RATIONALE FOR THE COURSE:**

In this course, we focus on providing a basic knowledge of child development, which will contribute to your understanding of children and your ability to support their growth and learning. You will learn about basic characteristics and developmental tasks of each stage of development from age three to age eight in order to properly care for and teach the child.

### **COURSE DESCRIPTION:**

This course is an in-depth study of preschool children growing and developing in today's world. Focus is on "total" development of the child with emphasis on physical, social, emotional, cognitive, and nutritional areas of development. Developmental tasks and appropriate activities are explored in the course.

### **PREREQUISITES/CO-REQUISITES:**

#### **Module 2:** Early Childhood Theory

**Material covered:** Early childhood theorists and theory implications

**Assessments:** Papers, Piagetian task interview

#### **Learning Outcomes:**

1. Research and identify early childhood theory and its influence on children's development and learning.
2. Plan age-appropriate activities and learning environments based on an understanding of child development and learning.

### **Module 3:** Case Study

**Material covered:** Observation, documentation, assessment of young children's development and learning

**Assessments:** Case study- mandatory

#### **Learning Outcomes:**

1. Use knowledge of children's characteristics, needs and influences on development and learning.
2. Use observation, documentation, and assessment to plan for and support young children's learning.
3. Use knowledge and appropriate learning standards to design meaningful learning experiences for an individual child.
4. Demonstrate professional behavior in class and during observations and field work.

Please note the College adheres to a 10 point grading scale A = 100 – 90, B = 89- 80, C = 79 – 70, D = 69 – 60, F = 59 and below.

Grades earned in courses impact academic progression and financial aid status. ## Part IV: Attendance

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. **Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.**
