RATIONALE FOR THE COURSE:

Methods and Materials is the preparation course for student teaching. A variety of types of plans and materials will be developed throughout the course with plan implementation occurring in student teaching sites.

COURSE DESCRIPTION:

This course includes an overview of developmentally-appropriate methods and materials for planning, and evaluating environments. Emphasis is on integrating divergent activities in each curriculum area.
