RATIONALE FOR THE COURSE:

EDU 102: Professional Preparation for Education Careers is a foundational course designed to equip aspiring educators with essential skills for success in the field of education. The course emphasizes creative and critical thinking skills, enabling future teachers to adapt and innovate in diverse classroom settings. Information literacy is also a key focus, ensuring students can responsibly navigate and utilize digital resources. Effective communication is vital for educators. EDU 102 improves both written and oral communication skills, essential for classroom teaching, collaboration with colleagues, and interaction with the educational community. Therefore, students are encouraged to set personal and academic goals while developing structured study habits. These skills are critical for academic success and professional growth. Another significant component of the course is targeted preparation for the PRAXIS I Core Academic Skills test, helping students meet certification requirements. In addition, the course includes a required field experience, allowing students to gain practical insights and apply theoretical knowledge in real-world educational settings. In summary, EDU 102 provides a comprehensive foundation in critical thinking, information literacy, communication, goal setting, study habits, and professional practice, preparing students for the PRAXIS I test and their future careers in education.

COURSE DESCRIPTION:

This course is designed to prepare students for careers in the education profession, including information literacy skills, PRAXIS preparation, academic and education career goals, recognition of appropriate resources for education majors, and preparation for professional program admission/success.

GRADING SYSTEM:

Please note the College adheres to a 10-point grading scale A = 100 - 90, B = 89-80, C = 79 - 70, D = 69 - 60, F = 59 and below.

Grades earned in courses impact academic progression and financial aid status. Before withdrawing from a course, be sure to talk with your instructor and financial aid counselor about the implications of that course of action. Ds, Fs, Ws, WFs and Is also negatively impact academic progression and financial aid status.

The Add/Drop Period is the first 5 days of the semester for **full term** classes. Add/Drop periods are shorter for accelerated format courses. Please refer to the <u>academic calendar</u> for deadlines for add/drop. You must attend at least one meeting of all of your classes during that period. If you do not, you will be dropped from the course(s) and your Financial Aid will be reduced accordingly.

Part IV: Attendance

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require

up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 -Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. **Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.**

For online and hybrid courses, check your Instructor's Course Information Sheet for any required on-site meeting times. Please note, instructors may require tests to be taken at approved testing sites, and if you use a testing center other than those provided by HGTC, the center may charge a fee for its services.

For this course, students may miss no more than 3 classes. For the hybrid class, arriving more than 15 minutes late or leaving more than 15 minutes early 3 times will constitute an absence.
