RATIONALE FOR THE COURSE:

This course serves as the foundation course in the understanding of AC and DC machine and their operation. This knowledge is needed for learners to understand how the many different types of machines operate proving the tools to successfully test, troubleshoot and repair complex automated systems.

COURSE DESCRIPTION:

This course is a study of applications, operations, and construction of DC and AC machines.
