RATIONALE FOR THE COURSE:

This course serves as a foundation prerequisite course for the mechatronics technology programs. Students are introduced to the fundamentals of digital electronic circuits, devices, and concepts. An understanding of these concepts will be a required prerequisite to understanding more the advanced studies in the mechatronics program

COURSE DESCRIPTION:

This course is a study of the logic elements, mathematics, components, and circuits utilized in digital equipment. Emphasis is placed on the function and operation of digital integrated circuit devices.

The Add/Drop Period is the first 5 days of the semester for **full term** classes. Add/Drop periods are shorter for accelerated format courses.
