COURSE PREFIX: EET 218 COURSE TITLE: Electrical Power Systems

CONTACT HOURS: 6 CREDIT HOURS: 4

RATIONALE FOR THE COURSE:

This is the study of the basic principles of electric power systems including: the characteristics of single and three phase electrical power systems, the generation, transmission, and distribution of electrical power. The electronic engineering technology student needs knowledge of electrical power systems to prepare them for the possibility of employment in this industry.

COURSE DESCRIPTION:

This course is a study of power generation, transmission, transformers, distribution, and motor controls.

PREREQUISITES/CO-REQUISITES:

Credit level EET 114 Minimum Grade of C or Credit level EET 114 Minimum Grade of TC

COURSE LEARNING OUTCOMES and ASSESSMENTS*:

Module 1

Materials Covered: The student will be able analyze single phase and 3 phase circuits and identify active, reactive and apparent power in circuits.

Assessments: homework, lab exercises, unit test

Learning Outcomes:

- 1. Analyze Active, Reactive, and Apparent power in transmission circuits.
- 2. Analyze 3 Phase circuits and construct circuits in the lag.
- 3. Describe the Power Triangle, Power Factor, and Phasors.
- 4. Define a reactive load and a reactive source.

Module 2

Materials Covered: The student will be able to analyze and describe transformers and their operation.

Assessments: homework, lab exercises, unit test

Learning Outcomes:

- 1. Describe the ideal transformer.
- 2. Describe practical transformers and the deviation from ideal.
- 3. Analyze primary and secondary impedance, current, and voltage.
- 4. Describe a transformer under load.

Module 3

Materials Covered: The student will be able to analyze 3 phase transformers and special applications of the transformers.

Assessments: homework, lab exercises, unit test

Learning Outcomes:

- 1. Analyze a 3 phase transformer.
- 2. Describe an autotransformer and high impedance transformers.
- 3. Analyze wye and delta connections

GRADING SYSTEM:

HGTC has a standardized, recommended grading scale for academic courses. The grading scale requires that grades within the indicated range be defined as follows:

A: 90-100 B: 80-89 C: 70-79 D: 60-69 F: Below 60

The following grades are used:

- A EXCELLENT: used in GPA calculations; carries a value of 4 quality points and earns credit hours.
- B ABOVE AVERAGE: used in GPA calculations; carries a value of 3 quality points and earns credit hours.
- C AVERAGE: used in GPA calculations; carries a value of 2 quality points and earns credit hours.
- D BELOW AVERAGE: used in GPA calculations; carries a value of 1 quality point and earns credit hours.
- F FAILURE: used in GPA calculations; carries a value of 0 quality points and earns 0 credit hours. (Hours attempted are used in GPA calculations.)
- I INCOMPLETE: does not affect GPA calculations; defaults to "F" automatically after one term if the incomplete work has not been completed and generates 0 quality points and 0 credit hours. (See special note below.)

WF - WITHDRAWN FAILURE: used in GPA calculations; carries a value of 0 quality points and earns 0 credit hours. (Hours attempted are used in GPA calculations.)

W - WITHDRAW: not used in GPA calculations; carries a value of 0 quality points and earns 0 credit hours. May be utilized when extenuating circumstances warrant.

Note: Regarding a grade of "I" (Incomplete): A grade of Incomplete ("I") is assigned when the student does not complete work or take the final exam due to illness or for other reasons over which the student has no control. This grade is given only with the approval of the professor involved. An incomplete must be completed by the end of the following term. Otherwise, the grade becomes an automatic failure ("F").

Grades earned in courses impact academic progression and financial aid status. Before withdrawing from a course, be sure to talk with your instructor and financial aid counselor about the implications of that course of action. Ds, Fs, Ws, WFs and Is also negatively impact academic progression and financial aid status.

The Add/Drop Period is the first 5 days of the semester for **full term** classes. Add/Drop periods are shorter for accelerated format courses. Please refer to the <u>academic calendar</u> for deadlines for add/drop. You must attend at least one meeting of all of your classes during that period. If you do not, you will be dropped from the course(s) and your Financial Aid will be reduced accordingly.

Part IV: Attendance

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. **Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.**

For online and hybrid courses, check your Instructor's Course Information Sheet for any required on-site meeting times. Please note, instructors may require tests to be taken at approved testing sites, and if you use a testing center other than those provided by HGTC, the center may charge a fee for its services.
