RATIONALE FOR THE COURSE:

To provide time for outside professionals to make presentations on career topics in the service area and for field trips by seniors and faculty to local industries which hire our graduates. This will broaden the seniors' understanding of the different areas of specialty within the Electronics Engineering Technology field and will introduce those outside professionals to our students which will enhance their employability.

COURSE DESCRIPTION:

This course includes various engineering topics, using field trips and discussions with practicing technical personnel. Proper use of test instruments is reinforced.

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance.
