### **RATIONALE FOR THE COURSE:**

To introduce the student to the origin, availability, and quality of common engineering materials. Emphasis will be on materials terminology and physical properties to provide the foundation for subsequent material courses.

### **COURSE DESCRIPTION:**

This course is a study of the properties, material behaviors, and applications of materials used in engineering structures and products.

9. Relate to the properties and composition of lumber materials.
10. Understand the process to produce paper, plastic and glass building construction products.
11. Select the appropriate painting and coatings, sealants, sealers and waterproofing materials for various applications.
12. Understand the properties of bituminous materials.
