RATIONALE FOR THE COURSE:

This course is a requirement for the Associates Degree in Civil/Electrical/General Engineering Technology and Construction Management Technology as well as the Surveying Certificate.

COURSE DESCRIPTION:

This course is a study of basic graphical concepts needed for engineering applications. (Transfer course). It will cover the basic use of the AutoCAD software. This course is intended to provide students with the capability to prepare CAD drawings using the AutoCAD software. It will cover lines and arcs, textstyles, dimensioning, hatching, auxiliary views, and editing entities.

Part IV: Attendance

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.

Please note, instructors may require tests to be taken at approved testing sites, and if you use a testing center other than those provided by HGTC, the center may charge a fee for its services.
