### **RATIONALE FOR THE COURSE:**

This course is a continuation of an earlier coursework (EGR 285, Engineering Surveying I) and designed to provide the student with an in depth knowledge of practices and application of surveying. The lab for this course (EGR 296) must be taken concurrently

This course covers land surveying and boundary laws, public land surveys, topographic mapping, horizontal and vertical curves, lot calculations, and engineering astronomy.

5. Identify the use of compound, reverse and spiral curves.
6. Recognize the legal aspects of land surveying as well as the Public Land Surveying System, while demonstrating the ability to communicate surveying information in a written format.
7. Recognize construction field control techniques.
8. Understand the use of the South Carolina Coordinate System including relevant facts.
9. Compute components of a typical vertical curve.
