### **RATIONALE FOR THE COURSE:**

To teach pictorial communication through the use of standards and techniques. Also, to teach compilation of ideas and information in pictorial form, with emphasis on size and shape and to interpret drawings produced by others.

### **COURSE DESCRIPTION:**

This course covers the basics of drafting, emphasizing line quality, lettering, and basic drafting conventions.

The student must provide a basic set of drawing instruments including compass, dividers, pencils, erasers, triangles (30-60 degree and 45-45 degree), scales (civil and architectural), cleaning pad, brush, curve, lettering guide bow compass, lead pointer, erasing shield, and drafting tape. **Note:** Although students are not required to purchase these items if they already have them. The items are

available in drafting package in the student book store.

Perform simple arithmetic operations with whole numbers and fractions. Ability to comprehend technical data as related to linear distance, size and shape.

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. **Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.**
