#### **RATIONALE FOR THE COURSE:**

The student shall apply skills and knowledge learned in previous courses to actual pre-hospital situations. The student, using the case review method, shall develop skills for written and oral medical reports. This will represent Phase III of the internship where the student should be moving into the team leader role while still under supervision.

#### **COURSE DESCRIPTION:**

This course will emphasize the knowledge and skills of emergency care in an E-911 ambulance setting. Focus is on the student and their ability to apply classroom knowledge during an emergency situation while treating a wide variety of patients.

#### PREREQUISITES/CO-REQUISITES:

Prerequisites: EMS 116 EMS 224, EMS 230, EMS 238

Corequisites: EMS 117, EMS 118, EMS 240, EMS 241, EMS 272

\*Online/Hybrid courses require students to complete the <u>Distance Learning Orientation</u> <u>Video</u> prior to enrolling in an online course.

#### **REQUIRED MATERIALS:**

#### **ADDITIONAL REQUIREMENTS:**

Receives calls from dispatchers, responds verbally to emergency calls, reads maps, drives ambulances to emergency sites, uses most expeditious route, and observes traffic ordinances and regulations.

Works as a member of a two-person team.

Determines nature and extent of illness or injury, takes pulse, blood pressure, visually observes changes in skin color, auscultate breath sounds, makes determination regarding patient status, establishes priority for emergency care, renders appropriate emergency care (based upon competency and certification level); may administer intravenous drugs of fluid replacement as directed by a physician and based upon competency and certification level. May use equipment (based upon competency and certification level) such as but not limited to, defibrillator, electrocardiograph, performs endotracheal intubation to open airways and to ventilate patient, inflates pneumatic counter-pressure devices to improve patient's blood circulation.

Assisting in lifting, carrying, and transporting patient to ambulance and on to a medical facility. Reassures patients and bystanders, avoids mishandling patient and undue haste, and searches for medical identification emblem to aid in care. Extricates patients from entrapment, assess extent of injury, uses prescribed techniques and appliances, radios dispatcher for additional assistance or services, provides light rescue service if required, provides additional emergency care following established protocols.

Complies with regulations in handling deceased, notifies authorities, and arranges for protection of property and evidence at scene. Determines appropriate facility to which patient will be transported, report nature and extent of injuries or illness to the facility, ask for direction from hospital physician or emergency department (based upon competency and certification level). Observes patient enroute and administers care as directed by physician or emergency department or according to published protocol based on competency and certification level. Identifies diagnostic signs that require communication with facility. Assist in removing patient from ambulance and into emergency facility. Reports verbally and in writing observations about and care of patients at the scene and enroute to facility, and assists emergency staff as required.

Replaces supplies, prepares and / or sends used supplies for sterilization and / or disposal in accordance with state and OSHA regulations and published standard operating procedures. Checks all equipment for future readiness, maintains ambulance in operable condition, ensures ambulance cleanliness and orderliness of equipment and supplies, decontaminates vehicle interior determines vehicle readiness by checking oil, gas, water in battery and radiator, and tire pressure, maintains familiarity with all specialized equipment.

#### ALL EMT'S MUST BE ABLE TO PERFORM THESE ESSENTIAL JOB FUNCTIONS:

- Ability to communicate verbally, via telephone and radio equipment;
- Ability to lift, carry, and balance up to 125 pounds (250 pounds with assistance);
- Ability to read and interpret written, oral, and diagnostic form instructions;
- Ability to use good sound judgment and remain calm in high-stress situations;
- Ability to work effectively in an environment with loud noises and flashing lights;

- Ability to function efficiently throughout an entire work shift;
- Ability to calculate weight and volume ratios and read small print, both under life threatening time constraints;
- Ability to read and understand English language manuals and road maps;
- Accurately discern street signs and address numbers;
- Ability to interview patient, family members, and bystanders; Ability to document, in writing, all relevant information in prescribed format in light of legal ramifications of such;
- Ability to converse in English with co-workers and hospital staff as to status of patient;
- Good manual dexterity, with ability to perform all tasks related to highest quality patient care;
- Ability to bend, stoop, and crawl on uneven terrain;
- Ability to withstand varied environmental conditions such as extreme heat, cold, and moisture;
- Ability to work in low light, confined spaces and other dangerous environments.

#### **TECHNICAL REQUIREMENTS:**

Access to Desire2Learn (D2L), HGTC's learning management system (LMS) used for course materials.

Access to myHGTC portal for student self-services.

College email access – this is the college's primary official form of communication.

#### STUDENT IDENTIFICATION VERIFICATION:

## **Part II: Student Learning Outcomes**

To prepare competent entry-level Emergency Medical Technician - Paramedics in the cognitive (knowledge), psychomotor (skills) and affective (behavior) learning domains.

#### **COURSE LEARNING OUTCOMES and ASSESSMENTS\*:**

Upon completion of this rotation the student should be able to:

1. Describe what is involved in the management and treatment plan of injured or ill patients with, compensated and decompensated shock, respiratory distress, respiratory failure,

<sup>\*</sup>Students must not have a family member as a preceptor. Family members include the following: parents, siblings, children, aunts, uncles, cousins including step-relatives.

- respiratory arrest, cardiac arrest, and other medical emergencies.
- 2. Describe what is involved in the management and treatment of trauma patients.
- 3. Recognize the difference between sick and not sick patients.
- 4. Recognize areas in patient care that need improvement.
- 5. Discuss a patient's complete medical history and treatment with the attending staff.
- 6. Demonstrate proper communication skills with medical staff and patients.
- 7. Discuss indications, dosages, route of administration and special considerations for medication administration in the emergency setting.
- 8. Demonstrate the ability to safely administer medications by Oral, IM, SubQ, and IV techniques.
- 9. Demonstrate appropriate intervention techniques with family and friends.
- 10. Attend to the need for reassurance, empathy, and compassion for the family and friends
- 11. Demonstrate and advocate appropriate interaction with injured and ill patients that conveys respect for their position in life.
- 12. Describe techniques for successful interaction with families and friends of injured and ill patients.
- 13. Demonstrate and develop patient assessment skills.
- 14. Demonstrate critical thinking skills in the emergency setting.
- 15. Demonstrate proper technique for intravenous access for injured and ill patients.
- 16. Develop teamwork skills by assisting the nursing staff in the care of emergency patients.
- 17. Demonstrate psychomotor skill related to treatment and care of emergency patients.
- 18. Demonstrate proper techniques for airway management in injured and ill patients to include oxygen delivery, suction, bag-valve-mask ventilation, LMA insertion, and endotracheal intubation.
- 19. Demonstrate appropriate treatment/management of intubation complications for patients with respiratory distress, failure, and arrest.
- 20. Discuss the treatment of injured and ill patients from admission to discharge.

<sup>\*</sup>Note: Students will need to obtain a minimum of 160 ambulance experience hours for this semester and should have a total of 320 hours or more before the EMS 272 capstone begins.

#### **GRADING SYSTEM:**

#### **ACCIDENT OCCURRING ON OR OFF CAMPUS**

Accidents involving Faculty, Staff and Student Workers (work-study, clinical student or students on a required internship):

If the incident is an emergency, please notify Human Resources as soon as the proper medical attention has been rendered for verification of workers' compensation coverage.

In any event, if an accident occurs, proper documentation needs to be completed. An accident report needs to be filled out stating the name of the injured party, the location of the accident, their identification number (social or H number), their address & phone number, the date & time of the accident, whether there were witnesses, and a brief description of what occurred. Attached is a copy of the Accident/Incident Report form. A copy of the report needs to be distributed to the following departments: Human Resources, the respective Supervisor, and the Dean/Provost of the specific campus.
