### **RATIONALE FOR THE COURSE:**

ENG 206 is the second half of a two-semester survey course of English language literature of the British Isles covering major extant material from the Romantic Period to the literature of the present. Students will demonstrate knowledge of the facets of Western achievement and culture through the study of the British literary heritage. In ENG 206, students build upon skills acquired in ENG 101 and 102. Discussion/lecture, close reading, research, analysis and explication will expose students to the major works of significant British writers from the Romantic Period to the present.

### **COURSE DESCRIPTION:**

This is a (college transfer) course in which the following topics are presented: the study of English literature from the Romantic period to the present with emphasis on major writers and periods.

For each of the Romantic, Victorian and 20<sup>th</sup> Century periods, students will describe, analyze and explain the historical and cultural perspectives, the major forms, works and significant writers in unit exams with essay components, out-of-class research papers, quizzes, and Discussion Postings.

1. Identify authors and works for the major period  
Identify authors during class discussions and in writing on exams and out-of-class assignments  
Connect authors and their works to their literary periods
2. Analyze social, historical, scientific, and artistic perspectives and their influences on literature
3. Analyze or explicate major genres and their works orally and in writing
4. Defend original interpretations or analysis with relevant evidence from primary and secondary sources
5. Synthesize several interpretations or analyses in focused, coherent essays that conform to MLA guidelines
6. Conduct research of secondary sources in a variety of media
7. Synthesize research into coherent essays focused on a clear thesis

## GRADING SYSTEM:

## Part IV: Attendance

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. **Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.**
