RATIONALE FOR THE COURSE:

ENG 209 is the second half of a two-semester survey course of World Literature in English translation covering major extant material from the Enlightenment to the literature of the present. Students will demonstrate knowledge of Western and non-Western literary achievement and culture through the study of major authors and their works. In ENG 209, students build upon skills acquired in ENG 101 and 102. Through the use of discussion/lecture, close reading, research, analysis and explication, students will closely study the major works of significant writers from the Enlightenment to the present.

COURSE DESCRIPTION:

This course is a study of masterpieces of world literature in translation from the seventeenth century to the present.

Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance.
