# **RATIONALE FOR THE COURSE:**

This course is designed to acquaint the student with the variety of forest trees in North America, their means of identification and major uses whether commercial, ornamental or for wildlife benefit. The basics of botany are also discussed to give the student an understanding of how the plant functions.

## **COURSE DESCRIPTION:**

This course is a study of the characteristics and uses of important trees, shrubs and lesser vegetation. It includes collecting, mounting, and identifying approximately 115-130 species common to the Southeast by leaf, twig, bark, and growth characteristics.

- 1. Identify how plant communities (trees, shrubs & other ground cover) develop on different land types: obligate wetland, facultative wetland, facultative, facultative upland and upland.
- 2. Identify the environmental factors that contribute to the development of a plant community (soils, climate, physiographic features, biota, etc.).
- 3. Identify the habits associations of a native, exotic, naturalized or invasive plants.
- 4. Identify why a plant is thought to be tolerant or Intolerant.
- 5. Identify and describe the North American major commercial species and their uses.

#### **GRADING SYSTEM:**

The College adheres to a 10 point grading scale A = 100 - 90, B = 89 - 80, C = 79 - 70, D = 69 - 60, F = 59 and below.

Grades earned in courses impact academic progression and financial aid status. # Part IV: Attendance

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. **Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.**
