RATIONALE FOR THE COURSE:

This course will instruct the student in the proper field techniques for conducting an estimation of standing timber.

COURSE DESCRIPTION:

This course is a study of the three systems of estimating volumes and values of standing timber-strip, plot, and prism. Stand analysis, dominant tree data, and statistical data are also collected and analyzed.

- 5. Explain the standard deviation and coefficient of variation as they apply to forestry decisions.
- 6. Estimate timber stand valuation
- 7. Stand and Stock Tables

Materials Covered: Forest Products Scaling, Tree Growth, Crown classification, Timber Marking * **Assessments:** Group activities, Worksheets, Quiz, 1 - Test

Learning Outcomes:

- 1. Knowledge of log scaling, grading, and tree defects.
- 2. Explain crown classification and its use in silvicultural operations
- 3. Define and calculate basal area.
- 4. Define timber product classes and their uses.
- 5. Identify regionally significant forest products and their sources.
- 6. Identify all measurements of stand density.
- 7. Identify timber marking techniques and procedures.

GRADING SYSTEM:

Please note the College adheres to a 10 point grading scale A = 100 - 90, B = 89 - 80, C = 79 - 70, D = 69 - 60, F = 59 and below.

Grades earned in courses impact academic progression and financial aid status. The Add/Drop Period is the first 5 days of the semester for **full term** classes. Add/Drop periods are shorter for accelerated format courses. Please refer to the <u>academic calendar</u> for deadlines for add/drop. You must attend at least one meeting of all of your classes during that period. If you do not, you will be dropped from the course(s) and your Financial Aid will be reduced accordingly.

Part IV: Attendance

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. **Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.**
