### RATIONALE FOR THE COURSE:

This course is designed to give students on-the-ground experience and exposure to the private or public sector of forestry and forest products, wildlife management, surveying or natural resource management, in preparation for the second year of coursework within the Forestry Management Technology curriculum.

### COURSE DESCRIPTION:

This course is a study of the problems of day to day natural resource operations. Employment by an approved forest or natural resource related industry or agency is required.

### INSTRUCTOR VISITS

### GRADING SYSTEM:

Grades earned in courses impact academic progression and financial aid status. ## Part IV: Attendance

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once

a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll.
