### **RATIONALE FOR THE COURSE:**

The use of Geographical Information Systems and related geospatial technology is used by organizations, businesses, and government agencies. This course will introduce techniques for collecting data and generating graphical information by using ESRI ArcGIS software and media.

### **COURSE DESCRIPTION:**

This course is a study of development of digital techniques to portray mapping/spatial data, hardware and software components of digital mapping systems, and review of basic procedures in creating, maintaining and utilizing digital mapping.
