RATIONALE FOR THE COURSE:

Operation and execution of a successful event requires successful planning and relationship building. Event management, at some level, happens in all facets of the hospitality industry. This course will prepare students to apply the basics of event planning including budgeting, preparation, timelines, schedules, vendor selection and communication and issues that may arise.

COURSE DESCRIPTION:

This course provides an introduction to the event management industry. Topics include planning, implementation and evaluation of special events and festivals.

GRADING SYSTEM:

Part IV: Attendance

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. **Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.**
