### **RATIONALE FOR THE COURSE:**

As human service workers, it is imperative that you evaluate and clarify personal beliefs relative to interpersonal relationships, interests, spirituality, death, and other core values that may impact the work that you do as a professional. Understanding how life choices impact the people that we become can enhance your overall well-being and the work that you will do with others. The course is designed as an entry-level course.

### **COURSE DESCRIPTION:**

This course provides students with the opportunity to gain a greater awareness of "self" through values clarification activities, reflective writings, etc., and to understand how attitudes, values and beliefs impact both their personal and professional lives.

**Learning Outcomes:**

1. Learn ways to love and appreciate ourselves.
2. Clarify your views and values pertaining to love.
3. Examine the guidelines for meaningful interpersonal relationships including social networking, online dating, and infidelity in cyberspace.
4. Identify intimate partner violence and abuse.
5. Reflect on gender roles that have influenced your view of what gender means to you, and on the choices you have made about your gender-role identity.
6. Identify male roles, female roles, gender-role conflict, gender-role socialization, women and work choices, and challenging traditional gender roles.
7. Identify and clarify the beliefs, attitudes, and values you hold regarding your sexuality and evaluate whether your sexual behavior is consistent with your beliefs, attitudes, and values.

**Learning Outcomes:**

1. Make an assessment of your personal interests, needs, values, and abilities and develop a plan to choose a career path.
2. Identify ways to find meaning in work and approaches to keep options open.
3. Define loneliness and solitude and the impact of loneliness in the age of connectivity and the stages of life.
4. Learn to confront the fear of loneliness.
5. Identify your attitudes and beliefs about death, your thoughts and feelings about your own mortality, your feelings about the eventual death of those you love, and other forms of significant loss.
6. Examine the link between spirituality/religion and meaning in life addressing ways we can embrace diversity and make a difference beyond ourselves.
7. Identify the barriers to seeking help.
8. List the important aspects of human service organizations, and trends in Human Services

#### **GRADING SYSTEM:**

Please note the College adheres to a 10-point grading scale A = 100 – 90, B = 89- 80, C = 79 – 70, D = 69 – 60, F = 59 and below.

Grades earned in courses impact academic progression and financial aid status. Ds, Fs, Ws, WFs and Is also negatively impact academic progression and financial aid status.

The Add/Drop Period is the first 5 days of the semester for **full term** classes. Add/Drop periods are shorter for accelerated format courses. If you do not, you will be dropped from the course(s) and your Financial Aid will be reduced accordingly.

## **Part IV: Attendance**

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. **Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.**
