### RATIONALE FOR THE COURSE:

Gerontology is the scientific study of the biological, psychological, and social aspects of aging. It is imperative that people who work with the elderly obtain an understanding of family relationships, health, economics, retirement, widowhood, and care of the frail elderly.

### COURSE DESCRIPTION:

This course is a survey of the physical, social, and mental changes that occur as a person ages. The related problems and current programs designed for people age 55 and over are studied in the course.

#### GRADING SYSTEM:

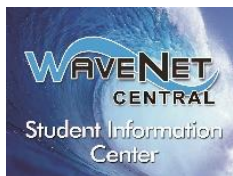
