RATIONALE FOR THE COURSE:

This course prepares the students to begin to explore and critically think about ethical decision making surrounding ethical dilemmas on topics such as countertransference, confidentiality, multiple relationships, informed consent, value conflicts, duty to warn or protect, and supervision. Students will consider themselves as future counselors when practicing and studying these skills through course materials provided.

COURSE DESCRIPTION:

This course is an in-depth analysis of human services ethics, application of NOHSE codes of ethics, and concepts and dilemmas specific to helping relationships.
