RATIONALE FOR THE COURSE:

The course is a study of domestic violence will primarily and child abuse. The domestic violence portion of the course will primarily focus on violence perpetrated by spouses/intimate partners on a female victim. Although the literature has documented that males can be victims of domestic violence, the course will focus on female victims because the prevalence of domestic violence by a male perpetrator against a female is higher. This course will not only review spousal abuse but will also explore the issues related to dating violence and child abuse.

COURSE DESCRIPTION:

This course studies special topics of interest to populations and locations.
