COURSE PREFIX: IST 162 COURSE TITLE: Introduction to Workstation Network Administration

CONTACT HOURS: 5 CREDIT HOURS: 3

RATIONALE FOR THE COURSE:

This is an introductory course in workstation management that is designed to give the student the basic tools needed to administer client/server networks. It is a required course for students who are completing their Computer Technology degree with an emphasis in networking. It is also required in several of the department's shorter certificate programs. Students must pass the course with a C or better to proceed to higher level networking classes.

COURSE DESCRIPTION:

This course is an introductory study of the administration of a single and multiple domain networks. Tasks will include handling user group accounts, resource management, permissions, ownership assignments, printing, security and backup.

Part IV: Attendance

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.
