RATIONALE FOR THE COURSE:

This course is a study of how computer architecture relates to the interconnecting of the various network components, the environment in which the applications processes execute and the overall plan defining services to be provided in a distributed environment.

COURSE DESCRIPTION:

This course is an advanced study of the networking operating system. Topics include installation upgrades, IP services, internet infrastructure, advanced server management and security, NDS management, and server optimization.

PREREQUISITES/CO-REQUISITES:

IST 165 Implementing & Administering Windows Directory Services (Grade of C or higher)
